There is an additional \$5 fee for adulterant detection.

Additional Information: Random urine analysis is offered. Monitored urine analysis is offered for males, in lieu of monitored urine analysis for females, saliva and hair follicle testing can be arranged.

Breath alcohol testing is \$25 and no charge for confirmation test. Prices are subject to change.

Additional Information: All tests are observed, but not random. Need to bring information for report release. Medical Review Officer (MRO) is available for \$10 or \$30.
